

## Niyo Wealth Terms and Conditions

Please read the following terms in respect of the Niyo Wealth ("Niyo Wealth") to be provided by Finnew Technologies Private Limited ("Niyo") available on the Niyo Global mobile application, referred as "Platforms").

- 1. You can use your Niyo account to log-in and use Niyo Wealth. The purpose of Niyo Wealth is to keep track and manage your personal finances and investments made by you.
- 1. If you have an account with Niyo, Niyo is providing you a non-exclusive, non-transferable, non-sublicensable, revocable, and single-use license to access Niyo Wealth. This license is for your personal use only, and not for any commercial license purposes.
- 1. You can now use the Platforms to invest in third party mutual fund scheme units and third party insurance policies ("Products").
- 1. [Please note, that fulfilment services of purchasing the Products is facilitated by Alphafront Finserv Private Limited ("Alphafront") (https://www.goalwise.com/). You agree that Niyo is not responsible for any services to be rendered by Alphafront in respect of purchase of the Products. You expressly agree that you have read and understood the terms and conditions of Alphafront (https://www.goalwise.com/terms) prior to using Niyo Wealth
- 1. For the purpose of utilising Niyo Wealth, you may be required to provide information/documents, other than what has already been provided to Niyo (all such existing and new information and documents, "Information"). You warrant that all Information provided by you for using Niyo Wealth is correct and accurate and belongs to you Further, you understand and agree that Alphafront is required to complete a KYC (Know Your Customer) process prior to you purchasing any Products. Therefore, you acknowledge and agree that until completion of the KYC process, you will not be able to use Niyo Wealth.

- 1. You authorise and agree that your Information will be shared with Alphafront, who will in turn share such Information with other third parties to facilitate completion of your transactions initiated under Niyo Wealth.

You agree to contact the Third Party Entity directly for any issue/query/dispute arising out of the Products purchased by You via the Platform.
- 1. You shall be responsible for all your financial transactions. You undertake to supervise and be responsible for accessing the Platforms under your account and absolve Niyo from any liability.

f. These terms are governed by the laws of India. All disputes are subject, firstly, to mediation, and then by arbitration by a sole arbitrator appointed by Niyo. The venue of arbitration will be Bangalore. Further, any matters arising under these terms shall be subject to the exclusive jurisdiction of courts located in Bangalore.
